'Vital Education - Psychedelic Insights Retreat' PROGRAM CLIENT AGREEMENT

This 'Vital Education - Psychedelic Insights Retreat' Program Client Agreement (“Agreement”) is between Psychedelic Insights BV., Dutch B.V. Netherlands (“Psychedelic Insights”), and the individual specified on the signature page of this Agreement (“Client”).

RECITALS

A. Psychedelic Insights is in the business of providing a psychedelic immersion retreat known as the “Vital Education - Psychedelic Insights Retreat” program (the “Vital Education - Psychedelic Insights Retreat' Program”).

B. The 'Vital Education - Psychedelic Insights Retreat' Program consists of: (i) two 30-minute digital preparation sessions (the “Preparation Sessions”), (ii) a five-day experiential retreat comprising two psychedelic ceremonies in the Netherlands (the “Netherlands Retreat”), and (iii) four 45-minute digital integration sessions (the “Integration Sessions”).

AGREEMENT

SECTION 1 'Vital Education - Psychedelic Insights Retreat' PROGRAM

1.1 'Vital Education - Psychedelic Insights Retreat' Program Dates. The term of this Agreement begins on the date of the first Preparation Session and will expire at the conclusion of the 4th Integration Session, which dates are listed on the program page; Exhibit A (the “Term”).

1.2 'Vital Education - Psychedelic Insights Retreat' Program webpage. Psychedelic Insights will deliver an 'Vital Education - Psychedelic Insights Retreat' Program webpage (the “Vital Education - Psychedelic Insights Retreat' Program Webpage”) to Client in conjunction with the Preparation Sessions and prior to the Netherlands Retreat.

1.3 'Vital Education - Psychedelic Insights Retreat' Program Location. The Preparation Sessions and Integration Sessions will take place digitally via Zoom. The Netherlands Retreat will take place at the Psychedelic Insights Lindehof Retreat Center in Linde, Denthe, The Netherlands.

SECTION 2 PRICE AND PAYMENT

2.1 Price and Payment.

The price for the 'Vital Education - Psychedelic Insights Retreat' Program is EUR€2,250 due and payable contemporaneously with the signing and delivery of this Agreement by Client.

Psychedelic Insights will provide for payment by Client by credit card via Paypal or other methods as provided on the webpage.

2.2 Expenses. Lodging and meals during the Netherlands Retreat will be provided by Psychedelic Insights; provided, including travel to and from the retreat location - however, that Psychedelic Insights is not responsible for any other expenses incurred by Client in connection with the 'Vital Education - Psychedelic Insights Retreat' Program, including but not limited to expenses for airline flights or accommodation outside of the retreat location.

SECTION 3 REPRESENTATIONS AND WARRANTIES OF CLIENT Client represents and warrants to Psychedelic Insights as follows:

3.1 Age and Capacity. Client is an individual at least 18 years of age. Client has the capacity, power, and authority to sign and deliver this Agreement and to perform all of Client's obligations under this Agreement. This Agreement is the legal, valid, and binding obligation of Client, enforceable against Client in accordance with its terms, except as enforceability

3.2 Accuracy of Client Information. All of the information that Client has provided to Psychedelic Insights before the signing and delivery of this Agreement, including but not limited to all of the information that Client provided to Psychedelic Insights in the Health Intake Questionnaire ("Original Client Information"), was and is accurate and complete in all respects, subject only to any corrections or changes that Client provided to Psychedelic Insights before the signing and delivery of this Agreement.

3.3 Acknowledgements. Client understands, acknowledges, and agrees that: (a) Psychedelic Insights is not requiring or encouraging Client to violate any applicable law; (b) although some of Psychedelic Insights' agents or representatives may be licensed mental health professionals, none of Psychedelic Insights' agents or representatives are or will be acting in their capacity as licensed mental health professionals in connection with the 'Vital Education - Psychedelic Insights Retreat' Program and will not be liable to Client as such; and (c) although Client and Client's facilitator at the Netherlands Retreat will collaborate to determine an appropriate dose of truffles containing psilocybin for Client to consume, Client's facilitator will make the final decision regarding an appropriate dose.

SECTION 4 OBLIGATIONS OF CLIENT

4.1 Rules and Requirements. Client will comply with the rules and requirements set forth on the attached Exhibit B and any reasonable modifications Psychedelic Insights, in its sole discretion, may make to the Rules and Regulations upon disclosure to Client (the "Rules and Requirements").

4.2 Client Information. If Psychedelic Insights requests Client to verify the continued accuracy of any Original Client Information, or if Psychedelic Insights requests Client to provide any new or additional information concerning Client ("New Client Information"), Client will promptly provide accurate responses to Psychedelic Insights. If circumstances change so that any Original Client Information or New Client Information is no longer accurate, Client will promptly notify Psychedelic Insights of such circumstances and describe to Psychedelic Insights in reasonable detail the information that is no longer accurate.

4.3 Indemnification. Client will defend and indemnify Psychedelic Insights for, from, and against any and all claims, actions, proceedings, damages, liabilities, and expenses of every kind, whether known or unknown, including but not limited to reasonable attorney's fees, resulting from or arising out of any breach by Client of this Agreement.

SECTION 5 PRIVACY POLICY Any and all Original Client Information and New Client Information that Client has provided to, or will provide to, Psychedelic Insights will be subject to

Psychedelic Insights' Privacy Policy set forth on the attached Exhibit C and on the page psychedelicinsights.com/legal.

SECTION 6 INTELLECTUAL PROPERTY Client understands, acknowledges, and agrees that as between Psychedelic Insights and Client, Psychedelic Insights is the sole and exclusive owner of: (a) all of the materials and information provided to Client by Psychedelic Insights in connection with the 'Vital Education - Psychedelic Insights Retreat' Program, including but not limited to the 'Vital Education - Psychedelic Insights Retreat' Program Webpage (the "Vital Education - Psychedelic Insights Retreat' Program"); and (b) all copyrights, trademark rights, and other 3 – 'Vital Education - Psychedelic Insights Retreat' PROGRAM

CLIENT AGREEMENT intellectual property and proprietary rights in the 'Vital Education - Psychedelic Insights Retreat' Program Materials ("Psychedelic Insights' Intellectual Property Rights"). Nothing in this Agreement, the 'Vital Education - Psychedelic Insights Retreat' Program, or the 'Vital Education - Psychedelic Insights Retreat' Program Materials is intended to transfer to Client any ownership rights in or to the 'Vital Education - Psychedelic Insights Retreat' Program Materials or Psychedelic Insights' Intellectual Property Rights. Client will not acquire any ownership rights in or to the 'Vital Education - Psychedelic Insights Retreat' Program Materials or Psychedelic Insights' Intellectual Property Rights as a result of Client participating in the 'Vital Education - Psychedelic Insights Retreat' Program. Client may not reproduce or disseminate to any person any written 'Vital Education - Psychedelic Insights Retreat' Program Materials without the prior written consent of Psychedelic Insights, which consent Psychedelic Insights may withhold in its sole discretion.

SECTION 7 LIMITED WARRANTY; DISCLAIMERS; LIMITATION OF LIABILITY; ASSUMPTION OF RISK

7.1 Limited Warranty. Psychedelic Insights warrants to Client that the 'Vital Education - Psychedelic Insights Retreat' Program components will be performed by qualified personnel in a professional manner.

7.2 General Disclaimer of Warranties. Except for the express limited warranty in Section 7.1, Psychedelic Insights expressly disclaims all warranties with respect to the 'Vital Education - Psychedelic Insights Retreat' Program, express and implied, including but not limited to any warranties that may have arisen or may arise from course of performance, course of dealing, or usage of trade.

7.3 Limitation of Liability. Psychedelic Insights' aggregate monetary liability to Client under this Agreement for any reason and for any and all causes of action, whether in contract, tort, or otherwise, will not exceed the amount that Client has actually paid to Psychedelic Insights under this Agreement. Notwithstanding any provision in this Agreement to the contrary, Psychedelic Insights will not be liable to Client under any cause of action, whether in contract, tort, or otherwise, for any indirect, special, incidental, consequential, or punitive damages, even if Psychedelic Insights has been advised of the possibility of such damages. Psychedelic Insights' price for the 'Vital Education - Psychedelic Insights Retreat' Program and Psychedelic Insights' obligations under this Agreement are consideration for limiting Psychedelic Insights' liability to Client.

7.4 Assumption of Risk. Client understands and acknowledges the following: • Certain activities in connection with the 'Vital Education - Psychedelic Insights Retreat' Program may involve an altered state of consciousness and may result in destabilizing psychological, emotional, spiritual, and physical responses.

• Although Client has been accepted for participation in the 'Vital Education - Psychedelic Insights Retreat' Program, Psychedelic Insights cannot guarantee Client's safety, Client is responsible for Client's own safety at all times during the 'Vital Education - Psychedelic Insights Retreat' Program, and Client will carefully follow instructions given by Psychedelic Insights or its agents to reduce or mitigate safety risks.

• Certain mental health conditions or behaviors, including but not limited to psychosis or psychotic disorders (such as schizophrenia, schizoaffective disorder, depression with psychotic features, or mania), personality disorders (such as borderline personality disorder), dissociative disorders (such as dissociative identity disorder), bipolar disorder, suicidal ideation or attempted suicide, past psychiatric hospitalization, and selfharm or self-destructive behavior (such as cutting, bruising, burning, or similar selfinflicted wounding; self-sabotage; problematic drug or alcohol use; or regular high-risk sexual behavior) may result in increased risks to Client.

• Certain genetic and biological predispositions, including but not limited to cardiovascular conditions (such as heart failure, heart attack, heart rhythm disorder, angina/myocardial infarction/myocardial ischemia, arrhythmias/pacemaker, stroke, moyamoya vasculitis, congestive heart failure, coronary artery disease, artificial heart valve, stents, or bypasses),

neurological conditions (such as brain tumor, pituitary disorder, epilepsy, dementia, amyotrophic

lateral sclerosis, Parkinson's disease, or multiple sclerosis), pregnancy, diabetes type I, Cushing's disease, liver disease, or COMT polymorphism, may result in increased risks to Client.

- In addition to the contraindications listed above, there may be innumerable other contraindications, or interactions with contraindications, that could result in increased risks to Client, including but not limited to illness, personal injury, psychological injury, unpleasant experiences, pain, suffering, disability, or death.

- Regardless of whether Client has any known or unknown contraindications, or no contraindications, Client is voluntarily participating in all activities related to the 'Vital Education - Psychedelic Insights Retreat' Program with knowledge of the dangerous activities involved and accepts and assumes all risks, including but not limited to illness, personal injury, psychological injury, unpleasant experience, pain, suffering, disability, or death, whether caused by the ordinary negligence of Psychedelic Insights or otherwise.

- Although Client has been accepted for participation in the 'Vital Education - Psychedelic Insights Retreat' Program, there are no guarantees Client will have an enjoyable experience, experience personal growth, or derive any value or benefit from the 'Vital Education - Psychedelic Insights Retreat' Program.

SECTION 8 FORCE MAJEURE EVENTS No party will be responsible for failure to perform the party's obligations under this Agreement due to contingencies beyond the party's reasonable control, including but not limited to the COVID-19 pandemic, other pandemics, earthquakes, floods, tornadoes, and other acts of Nature, fires, wars, riots, revolutions, acts of civil or military authorities, acts of terrorism, sabotage, or nuclear incidents (each, a "Force Majeure Event"); provided however, that nothing in this Section 8 will restrict either party's right to terminate this Agreement under Section 9. If any obligation of a party will be delayed by a Force Majeure Event, the party will promptly notify the other party.

SECTION 9 TERMINATION

9.1 Termination by Psychedelic Insights. Psychedelic Insights may terminate this Agreement upon written notice to Client if: (a) Client fails to make any payment required by this Agreement when due; (b) Client breaches this Agreement (other than by failing to pay any amounts due under this Agreement when due) and fails to cure such breach within 10 days after Psychedelic Insights notifies Client of the breach; (c) Client breaches this Agreement after Client has received two or more prior notices relating to prior breaches of this Agreement; (d) Client willfully engages in dishonesty, illegal conduct, gross misconduct, or abusive, defamatory, or derogatory acts or speech based on race, sex, sexual orientation, gender identity, age, religious or political beliefs, disabilities, ethnicity, or nationality in connection with the 'Vital Education - Psychedelic

Insights Retreat' Program; (e) any material Original Client Information or New Client Information that Client provided to Psychedelic Insights is found to have been untrue or becomes untrue in any material respect; or (g) a Force Majeure Event occurs and delays a material obligation of either party for more than 30 days.

9.2 Termination by Client. Client may terminate this Agreement upon written notice to Psychedelic Insights: (a) if Psychedelic Insights materially breaches this Agreement and fails to cure such breach within 30 days after Client notifies Psychedelic Insights of the breach; (b) if a Force Majeure Event occurs and delays a material obligation of either party for more than 30 days; or (c) upon notice to Psychedelic Insights, at any time for any reason.

9.3 Payment Refunds. If Client terminates this Agreement under Section 9.2(a), Psychedelic Insights will refund to Client the entire amount that Client has actually paid to Psychedelic Insights under this Agreement. If Client terminates this Agreement under Section 9.2(b), Psychedelic Insights will retain as a "credit" the entire amount that Client has actually paid to Psychedelic Insights under this Agreement and Client may re-enroll in the 'Vital Education - Psychedelic Insights Retreat' Program within 12 months of the date of termination if clients so wishes. If Client is located in the European Union and terminates this Agreement under Section

9.2(c) within 14 calendar days from the date Client signed this Agreement, Psychedelic Insights will refund to Client the entire amount that Client has actually paid to Psychedelic Insights (subject to any exceptions under the laws of the specific jurisdiction of Client). If Client terminates this Agreement under Section

9.2(c), and Client (a) is not located in the European Union, or (b) is located in the European Union and terminates this Agreement more than 14 calendar days from the date Client signed this Agreement, Psychedelic Insights will refund Client as follows:

TIME FRAME REFUND TERMS 120 or more days from date of the first Preparation Session
Entire amount that Client has paid to Psychedelic Insights.

9.4 Revocation of Participation and Access. Client acknowledges and agrees that in the event this Agreement is terminated under this Section 9, Client will be prohibited from further participation in the 'Vital Education - Psychedelic Insights Retreat' Program.

9.5 Effect Generally. The termination of this Agreement, regardless of how it occurs, will not relieve a party of obligations that have accrued before the termination. All provisions of this Agreement that would reasonably be expected to survive the termination of this Agreement will do so.

SECTION 10 GENERAL

10.1 General. This Agreement is personal to Client. Client may not assign or delegate any of Client's rights or obligations under this Agreement to any person without the prior written consent of Psychedelic Insights, which consent Psychedelic Insights may withhold in its sole discretion. This Agreement will be binding on the parties and their respective heirs, personal representatives, successors, and permitted assigns, and will inure to their benefit. This Agreement may be amended only by a written document signed by Client and Psychedelic

Insights. No waiver will be binding on a party unless it is in writing and signed by the party making the waiver. A party's waiver of a breach of a provision of this Agreement will not be a waiver of any other provision or a waiver of a subsequent breach of the same provision. If a provision of this Agreement is determined to be unenforceable in any respect, the enforceability of the provision in any other respect and of the remaining provisions of this Agreement will not be impaired. The parties will sign other documents and take other actions reasonably necessary to further effect and evidence this Agreement. The parties do not intend to confer any right or remedy on any third party. All exhibits and other attachments referenced in this Agreement are part of this Agreement. This Agreement may be signed in counterparts. An electronic transmission of a signature page will be considered an original signature page. At the request of a party, each other party will confirm an electronically transmitted signature page by delivering an original signature page to the requesting party.

10.2 Governing Law. This Agreement is governed by the laws of the Netherlands, without giving effect to any conflict-of-law principle that would result in the laws of any other jurisdiction governing this Agreement. Subject to the terms and conditions of this Agreement, the parties will have all remedies available to them at law or in equity. All available remedies are cumulative and may be exercised singularly or concurrently. Mandatory provisions of Dutch law shall have an effect on the terms and conditions of this Agreement.

10.3 Competent Court. Any dispute, controversy, or claim arising out of the subject matter of this Agreement will be exclusively settled by the competent court in Amsterdam.

10.4 Entire Agreement. This Agreement contains the entire understanding of the parties regarding the subject matter of this Agreement and supersedes all prior and contemporaneous negotiations and agreements, whether written or oral, between the parties with respect to the subject matter of this Agreement. During the Term of this Agreement, Client will: a. act in a manner consistent with Psychedelic Insights' core values of collaboration, transparency, access, sustainability and inclusivity; b. monitor Client's mental and physical health and wellbeing and take responsibility for Client's self-care; c. pay careful attention to any signs in Client of emotional distress, trauma symptoms, discomfort, or dysregulation and seek the help of a mental health professional if Client needs; d. reach out to Psychedelic Insights staff if Client is experiencing challenges in completing the 'Vital Education - Psychedelic Insights Retreat' Program for any reason; e. demonstrate consideration and respect for others in connection with the 'Vital Education - Psychedelic Insights Retreat' Program, including by respecting the individual experiences and journeys of other 'Vital Education - Psychedelic Insights Retreat' Program participants; f. not engage in abusive, defamatory, or derogatory acts or speech based on race, sex, sexual orientation, gender identity, age, religious or political beliefs, disabilities, ethnicity, or nationality in connection with the 'Vital Education - Psychedelic Insights Retreat' Program; g. not disrupt the learning of other 'Vital Education - Psychedelic Insights Retreat' Program participants; h. refrain from giving advice or colluding over shared stories of victimization; i. refrain from sharing or posting the Psychedelic Insights logo or brand identity in any way publicly and be mindful of public speech regarding the 'Vital Education - Psychedelic Insights Retreat' Program and psychedelics in any form of media, including but not limited to social media or news outlets (if in doubt, Client may email [support@Psychedelic Insightsinstitute.com](mailto:support@PsychedelicInsightsinstitute.com) for permission); j. not attend

any 'Vital Education - Psychedelic Insights Retreat' Program sessions under the influence of any alcohol, drugs, or other awareness-altering substances; k. not market any services or products of Client or others to other 'Vital Education - Psychedelic Insights Retreat' Program participants; and l. keep the identity and personal information of any other 'Vital Education - Psychedelic Insights Retreat' Program participants and staff members, agents, faculty, or volunteers of Psychedelic Insights confidential by refraining from using any names or other identifying information or taking any photos, videos, or audio recordings of such individuals. 2. Requirements. Client must attend all Preparation Sessions to qualify for attendance at the Netherlands Retreat. The Preparation Sessions, Netherlands Retreat, and Integration Sessions are mandatory.

Client may authorize Psychedelic Insights to disclose any of Client's information to a third party in writing signed by the Client. Client's Personal Information will not be used by Psychedelic Insights for any purpose other than for providing Client with the Services specified herein without Client's express written consent. Notwithstanding the foregoing, Psychedelic Insights may disclose Client's Personal Information when necessary to protect the safety of Client or another person or as otherwise required by law, court order, or legal process, including in a response to any governmental or regulatory request. Psychedelic Insights will not use Client's image or voice for any reason without the written consent of Client.
